## *Application Checklist*

### *Vehicle Loans*

Contact your local Capitol Federal branch to apply for a Vehicle loan.

At the time of application, please have available the following information:

- Complete the “Credit Application” in its entirety and return it to us. Remember to sign and date the form. Complete the names, addresses, and loan numbers of other creditors. Include also any rent payment and the name of the landlord.
- Copies of two consecutive, recent pay stubs for each applicant. The previous year’s W-2’s also will be required if the paystubs cover a period of time less than six months or if there has been a change of employment within the last two years.
- Self-employed persons and applicants otherwise relying on a significant amount of business income (such as commissioned salespersons) must furnish complete copies of the previous two years’ tax returns.
- The name, address, and loan number of the existing lienholder, if that lienholder will be paid off with the proceeds of this loan.
- A copy of the purchase contract, if the vehicle is a new purchase, or a copy of the existing title if the vehicle is pre-owned. Capitol Federal may require an inspection of pre-owned vehicles.
- Select a payment date of the first, tenth, or twentieth of the month.
- The name, address, and telephone number of your insurance agent.
- Complete, sign and date, and return the “Authorization to Release Information” form.

Picture identification is REQUIRED for ALL parties before the loan closing can be completed. This documentation cannot be expired. Remember to bring this documentation not later than at loan closing.
